As per the recommendation of the Affiliation Committee meeting held on 29.11.2024 vide additional agenda, ratified by the Governing Body in the Meeting held on 26.12.2024 vide Agenda Item XVII and subsequent approval of the Controlling Authority of the Board, the following amendments has been made in Clause 2.3.5 of Affiliation Bye Laws 2018 which shall be applicable on applications of schools for affiliation under different categories for the session 2026-27 to be registered on SARAS 6.0 Portal.

Accordingly, following amendments in the Affiliation Bye Laws 2018 are hereby notified:-

Existing Rule	Amended Rule
<b>Clause 2.3.5 :-</b> <b>NO OBJECTION FROM THE RESPECTIVE STATE GOVERNMENT</b> The Schools mentioned under clauses 2.1.5, 2.1.6, 2.1.7 and 2.1.8, seeking affiliation with the Board shall submit formal prior "No Objection Certificate" to the effect that State Government has no objection to the affiliation of the School with CBSE. No objection Certificate once issued to any school will be considered at par even if it prescribes a specific period and / or level unless it is withdrawn.	<b>Clause 2.3.5:-</b> <b>NO OBJECTION FROM THE RESPECTIVE STATE GOVERNMENT</b> The Schools mentioned under clauses 2.1.5, 2.1.6, 2.1.7 and 2.1.8, seeking affiliation with the Board are henceforth, will be permitted to apply on SARAS Panel for affiliation under various categories with or without NOC (No Objection Certificate) from the forthcoming sessions w.e.f. the session 2026-27.  In case, the school applies for affiliation without NOC, then the Board shall write to the concerned State Government to obtain their comments, if any, on the application of the school for affiliation with the Board. The department may furnish its comments regarding the said application, if any, at the link provided in the letter within 30 days of issue of the said letter. In case no comments are received within the said period of 30 days, a reminder letter will be sent to the concerned State Education Department to raise their objection, if any, within another 15 days, failing which, it shall be deemed that the State Government do not have any objection on the grant of affiliation to the school by the Board and the application of the school will be considered for grant of affiliation, if it otherwise, fulfils the conditions for grant of Affiliation as per the Affiliation Bye-Laws-2018 of the Board.

for Class 1<sup>st</sup> to Class 8<sup>th</sup> w.e.f from 1<sup>st</sup> April 2017.

The above sanction is subject to fulfillment of following conditions:-

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
2. The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules, 2009 (Annexure II).
3. The School shall admit in class I, to the extent of 25 % of the strength of that class, children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion. Provided, further that in case of pre primary classes also, this norm shall be followed.
4. For the children referred to in paragraph 3, the School shall be reimbursed as per Section 12(2) of the Act. To receive such reimbursements school shall provide a separate bank account.
5. The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
6. The School shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended provided prescribed for admission. On the ground of religion, caste or race, place of birth or any of them.
7. The School shall ensure:
  - (i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
  - (ii) No child shall be subjected to physical punishment or mental harassment;
  - (iii) No child is required to pass any board examination till the completion of elementary education;
  - (iv) Every child completing elementary education shall be awarded a certificate as laid down under Rule 23.
  - (v) Inclusion of Students with disabilities/special needs as per provision of the Act
  - (vi) The teachers are recruited with minimum qualifications as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years;
  - (vii) The teacher performs its duties specified under section 24(1) of the Act and
  - (viii) The teachers shall not engage himself or herself for private teaching activities.
8. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.

9. The School shall enroll students proportionate to the facilities available in the school as prescribed in the section 19 of the Act.
10. The School shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-
